The pallet option is only available in Mainland England and Wales at these prices. All other areas would be collected on a POA (Price on Application) basis.

This option is for empty, Contaminated Resin Containers based on the site having fork lifts to assist in loading palletised waste and that pallets are shrink wrapped and suitable for transportation.

Consignment notes are charged per load rather than per pallet. Maximum load collected is 14 pallets on a single layer.

If you are a producer of hazardous waste in Wales, should you produce in excess of 500lt/kg per annum, your site/s will need to be registered with Natural Resources Wales on the Hazardous Waste Register. We can do this on your behalf at a cost of **£28.00**. If you have registered already, please provide the registration code and expiry date at time of the service booking.

The above price allows for removal and authorised disposal within the Environmental Protection Act and in accordance with our Registered Waste Carriers Licence BUS/722000/CB.

Terms

This quotation is subject to:

- The packaging can be mixed i.e. Metal containers, Plastic tubs and paper bags
- Residues to be less than 1% of packaging size
- If the resins are mixed/reacted (gone hard) then 50/75mm in the bottom is acceptable
- Maximum weight per pallet at the above rate is 100kg's. Anything above this will be charged at £0.95 per kg.
- Pallet size should be no larger than 1200mm x 1200mm and stacked no higher than 1200mm and wrapped for secure transportation.
- The vehicles have loading ramps or tail lifts however, a fork lift will be required to get the pallets to the vehicles
- Due to volumes of work and transport working in certain regions on certain days, we work within a 7-10 working day turnaround time however, we do aim to get jobs done much sooner if transport is in a certain area. We will always be able to give a proposed collection date prior to any order being received, when requested. If this date is acceptable, it is valid, as long as a purchase order is received by us before 4.15 pm on the day that we provide the proposed collection date.
- The addition of VAT at the rate prevailing at the time of invoice
- Where applicable and at time of invoice, estimated weights may be used to determine the price and on confirmation of the actual weight, a supplementary invoice may follow to cover any under charges
- Landfill Tax at the current rate is included unless otherwise stated
