UPDATED SITE OPERATING PROCEDURES

On the 15th April, the Construction Leadership Council made available a new version of the Site Operating Procedures, designed to keep construction sites, including resin flooring work, operational in a safe manner during the coronavirus pandemic. FeRFA has been instrumental in helping develop the latest version, via its discussions with Build UK. The document is based on Public Health England guidance on social distancing and has support from across the industry, as well as from Government. The most important updates in the new version of the document are:

- Confirmation that the HSE is the enforcing authority for the Public Health England guidelines;
- A requirement for sites to monitor the implementation of the procedures;

Further details on who should not travel to work;

- Guidance for those who have no option but to share transport to work;
 - Planning of work to avoid close working;
 - First aid and emergency service issues.

VI DISTRIBUTION CONTINUE TO OPERATE AND DELIVER

VI continues to operate with a reduced number of staff, where possible staff are working from home and in line with government advice the warehouse continues to dispatch orders on a daily basis.

Supply Chain and Product Update

In order to help keep sites operational and to keep the construction and other industries open, VI are working hard to improve availability of all standard stocked items along with an increased range of cleaning and sanitising products and general site operating supplies, all in line with the government advice and changes to the Site Operating Procedures (SOP).

One challenge faced has been the break down in certain supply chains, some manufacturers for the time being have closed and others offer a reduced service.

That said the stock of VI's most popular items are holding up well.

One area of stock which has been affected is certain items of PPE.

Much has been said regarding PPE availability in the press and VI have been seeing this on some of the products that would normally be stocked.

Understandably manufacturers are prioritising the NHS and healthcare providers and therefore those said items are becoming harder to source in terms of availability and price.

If you are not already submitting your recycling data to FeRFA please start doing this now to qualify for the recycling logo within your FeRFA website entry.

It is easy to do using the datasheet (if not using Reconomy) - only two figures are needed per month - total weight collected and total weight recycled or recovered. This is information that should be provided by your waste collector. If it isn't then ask them why not. The spreadsheet includes a graph, automatically generated from your figures - which you can show to prospective clients
