GLOBAL RAW MATERIAL SHORTAGES CONTINUE

Global supply chain shortages for many key raw materials have been impacting resin flooring manufacturers since the end of 2020 contributing to sharp price increases and supply bottlenecks and further compounding the already existing pressures caused by the COVID-19 pandemic.

These issues are due to many diverse factors including core chemical material supply problems, forced shutdowns due to industrial accidents and severe weather conditions, mandatory factory maintenance shutdowns and lack of labour due to Covid 19 restrictions.

Some manufacturers are experiencing additional friction and costs caused by Brexit and the new trading conditions the UK has with the EU where most of the UK industry's raw materials are sourced. The situation is being compounded by a global shortage of shipping containers which has led to a sharp rise in transport costs from Asia to Europe thus further restricting supplies.

Some examples of the diverse nature of recent problems affecting the global raw material supply to the resin flooring market are as follows:

In February, the United States was hit with Winter Storm Uri resulting in disruption to power and water services and raw material supply to plants in Texas which led to a tightening in supply of bisphenol A (BPA), a crucial feedstock for epoxy resins.

During October and November, isocyanate supply in North America tightened following planned and unplanned shutdowns as the US Gulf Coast saw one of the worst hurricane seasons in years.

In November, a plant in Germany manufacturing isocyanates, mainly those used for UV stable polyurethane coatings, experienced a fire resulting in production of HDI and related derivatives used to manufacture epoxy curing agents being restricted due to force majeure.

The export of castor oil derivatives used to manufacture polyurethane resins from India where more than 80% of the world's castor seeds are grown came to a virtual standstill in early April because of actions taken by the Indian government to prevent the spread of Covid-19.

The Construction Leadership Council's Product Availability Working Group has issued a statement on the availability of construction products, which confirms that 'in addition to availability and resulting longer lead times, there is an impact on prices'. The products that are most affected are timber, steel, pitched roofing, plastics, cement and surface coatings. Specific information relating to surface coatings can be found by clicking the 'Coatings' link near the bottom of the statement.

Fire Safety Bill Becomes Law

The Fire Safety Bill has now received royal assent and passed into law on 29 April. A Lords amendment that would have prevented building owners passing on remediation costs to leaseholders was defeated during the process. The Fire Safety Act clarifies that the Fire Safety Order applies to the structure, external walls and any communal areas of buildings containing two or more domestic premises. It also clarifies that references to external walls include doors or windows in those walls, and anything attached to their exterior, including balconies.

The Act applies to England and Wales and together with the **Building Safety Bill** will form the Government's new building safety regime.

Product Testing Review

Former Chief Construction Adviser Paul Morrell OBE is chairing an **independent review of the system for testing construction products**. Build UK and its members will be
contributing to the review, which will examine how to strengthen the current system for
testing and certifying construction products to provide confidence they are safe and
perform as marketed.

CITB has published its **Levy Proposals for 2022-2025**, which would see rates return to 0.35% for PAYE staff and 1.25% for CIS sub-contractors for the next three years. A number of temporary measures introduced in the 2021 Levy Order would be maintained, including the increase in the Levy Exemption Threshold to £120,000 and the 50% reduction in Levy rates for employers with wage bills between £120,000 and £400,000. In line with CITB's Consensus process, Build UK will be formally consulting Levy-paying members on the proposals from 14 June to 30 July.

All Levy-registered employers should have now received their **2021 Levy Return**, and members are reminded to list all the trade bodies they are a member of when completing and returning it by the deadline of **Wednesday 30 June**.



Changes to Prompt Payment Code

The Small Business Commissioner, Philip King, joined a meeting with Build UK members earlier this month to discuss the **changes to the Prompt Payment Code**, including the new requirement to pay 95% of invoices from businesses with fewer than 50 employees within 30 days from 1 July 2021. We have produced a **summary** of the key points which answers the range of queries raised by members.

Build UK members can use the **Common Assessment Standard** to identify suppliers with fewer than 50 employees.

Question 10 asks 'Are you a Micro, a Small or a Medium-Sized Enterprise?' and any suppliers that state they are 'Micro' or 'Small' have fewer than 50 employees, in accordance with the EC definitions used within the standard, and this information is independently verified by a certification body on an annual basis.

Free EDI Training

Small and medium sized businesses can access **free online training resources** to help them meet the Equality, Diversity and Inclusion (EDI) requirements of their clients - such as Highways England, Network Rail and Transport for London - and recruit and retain from the full pool of talent.

People Survey Results Published

The results of the third cross-industry 'People Survey', carried out by Build UK on behalf of the CLC in April, have now been published. Providing an up-to-date snapshot of the ongoing impact of the coronavirus pandemic on the construction workforce, **Maintaining**Employment in Construction indicates that there will be a reduction of 1.2% in the size of the workforce by July. However, the number of apprentices employed is expected to increase by 2.7 % over the next three months, and the number of graduates taken on this September is expected to be 17% higher than last September.

Build UK has produced an easy to follow **flowchart** on the process of employing a foreign worker, which covers the EU Settlement Scheme, the Points-Based Immigration System and the Skilled Worker Visa, with links to further guidance where required. As part of the Government's **Help to Grow** scheme, a free 12-week programme for small businesses will be launched in June. 'Help to Grow: Management' is designed to be manageable alongside full-time work and covers key areas such as financial management, innovation and digital adoption, with one-on-one support from a business mentor. Delivered by leading business schools across the country, the programme will help business leaders to develop a tailored growth plan, and businesses with between 5 and 249 employees can **register their interest** now.

Common Assessment Standard Rollout

There are now 10 major Contractors and Clients specifying the Common Assessment Standard after Kier, Sir Robert McAlpine and Derwent London became the latest organisations to confirm they have adopted it for their pre-qualification requirements. The full list is available on the Build WK website and members of the supply chain can obtain the Common Assessment Standard from any one of three Recognised Assessment Bodies - Achilles, CHAS or Constructionline.

The <u>Common Assessment Standard</u>, which is endorsed by the CLC, has two levels of certification - desktop and site-based - and companies should apply for the appropriate level dependent upon their trade, size and requirements of their clients. Companies that are certified against the standard by a Recognised Assessment Body can use the appropriate version of the Common Assessment Standard logo.




