Government Simplifies Rules on UKCA Marking

UK Conformity Assessed (UKCA) marking is replacing CE marking and the Government has **announced changes** to make it simpler for businesses to apply the UKCA mark for most products placed on the GB market (England, Scotland and Wales) from **1st January 2023**:

- For products that have already been tested by an EU notified body by the end of 2022, including construction products under AVCP, manufacturers will be able to apply the UKCA mark without the need to re-test.
- Spares will continue to be accepted onto the GB market where they comply with the same requirements that were in place at the time the original products or systems they are being used to repair, replace or maintain were placed on the market.

 The need to re-test existing imported stock will be removed, allowing CE marked products that are imported into the UK by the end of 2022 to be sold without the need to meet UKCA requirements.

Whilst further guidance is expected, if a construction product is covered under AVCP system 3 and placed on the GB market, either for the first time or after it has been modified, from 1st January 2023, then it will need to be tested by a UK notified body to achieve the UKCA mark.

Help to Grow: Digital will offer free impartial guidance via an online platform to help SMEs identify their digital technology needs, assess technology purchasing options and implement new technologies in their operations. It will also offer eligible businesses a voucher covering up to half of the costs of preapproved, new-to-firm digital technology solutions up to a maximum of £5,000.



Help to Grow: Management is an intensive 12-week national training programme, that looks to improve SME leadership and management skills. Participating business leaders develop their skills in areas such as financial management, innovation, and digital adoption, and develop a tailored business growth plan to lead their business to its full potential.

Enrolling now for next training intake commencing September 2022

FeRFA has been successfully running training schemes since 2006, enabling employers to raise the skills level within their companies and provide a route for unskilled employees to gain an industry-wide recognised qualification and the CSCS blue Skilled Worker card.

FeRFA currently offers two Specialist Applied Skills Programme (SAP) schemes for all newcomers to the industry:

In Situ Flooring: Resin
Prepare and Profile Substrates

Both courses run for 18 months and lead to an NVQ level 2 Diploma and CSCS Blue Skilled Card.

All schemes are supported by the CITB and grant funded for CITB levy-payers and there is no upper age limit for trainees.

The modules are taken at various locations around the country, including the training facilities of FeRFA manufacturer and associate members.

BMW and MINI are some of the motoring industry's biggest and most prestigious manufacturers. The Swindon site is part of BMW Group's international production network for both BMW and MINI models.

Why they got in touch with Central Flooring

Central Flooring Services have been working with BMW for more than 12-months on resin flooring projects. This time they had a demarcation job which was 3000 linear metres of line marking – with crossing and hatching walkways.

About the project

Planning for this project was meticulous – work was carried out during the client's normal busy production to make absolutely sure that they didn't interrupt their flow.

On top of what they had planned, they were asked to carry out lots of additional work, which they still completed on time – no problem.

Johnnie Walker Experience: Princes Street, Edinburgh

Ancorite Surface Protection are proud to have been involved in the delivery of the prestigious floor finishes package for Diageo's flagship Johnnie Walker Visitor Experience, located on Princes Street in the heart of Edinburgh.

Ancorite was tasked to realise a stunning conceptual vision that would turn the former landmark department store building into a modern and interactive space, whilst retaining its original elegance.

The flooring package developed by the Design team needed to meet the varied challenges that this old eight-level floor building presented. The team opted for CPG Flowcrete as the preferred manufacturer due to its product range, which offered a varied and comprehensive system from initial sub floor renovation to final high-end aesthetic resin finishes.

The floor systems installed started with the renovation of the sub floor, and Flowcrete K screed and Isocrete systems were used to repair and level the floors throughout the whole

building.

The floor finishes specified for the prestigious visitor areas and main feature staircase were required to be of a high aesthetic quality, be hard wearing and easily maintained. The system had to be versatile so it could be formed seamlessly to the large floor areas as well as be suitable to be manufactured accurately to create nearly two hundred precast stair treads, risers and nosings.

The Flowcrete Mondeco Resin Terrazzo system was chosen as it offered all of the above and more.

Utilising different terrazzo colours and solid brass inlays, the system delivered a beautiful floor that accentuated the quality and style of the build throughout.

In addition, Ancorite was also tasked with several specific floor systems to meet other site requirements – from comfort floor resin to the whisky tasting bar room and visitor areas, to anti-static floor to the whisky cellar area and general plant room, and epoxy floor finishes to the back of house.
